

BIG JOE WARRANTY

Your BIG JOE lift truck is warranted for **one** (1) year from date of shipment to the original purchaser, on the frame, transmission, and weldments; for **six** (6) months from date of shipment on transistor control components, traction motor, lift motor, hydraulic pump, wiring harness assemblies, hydraulic hoses, cylinder packing, bearings, springs, and control cables; and for **three** (3) months from date of shipment on maintenance items which include tires, motor brushes, contact tips, switches, built-in chargers, and other components not previously covered.

This warranty is limited to replacing defective parts and providing the labor thereof for the first **ninety** (90) days from date of shipment. During the balance of any warranty period, we will replace defective parts and components. Labor and transportation will be charged as required. Any repair or replacement under this warranty must be authorized by BIG LIFT LLC and be accomplished by BIG LIFT LLC or its authorized dealer.

Warranty is void on equipment used in brine, corrosive conditions, or excessive moisture. When equipped with a cold conditioning package, the warranty shall be limited to ninety (90) days on all components.

Warranty does not cover maintenance items, including but not limited to, lubricating grease and oils, filters, or minor adjustments, or any items which show evidence of neglect, overload, abuse, accident, or inadequate maintenance. It is the user's responsibility to maintain it in accordance with BIG JOE'S recommended schedule of maintenance, as outlined in the operator's manual.

Warranty does not apply to other than BIG JOE attachments. Such attachments are covered by the warranties, if any, of the manufacturers of those products.

THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, WRITTEN OR ORAL; INCLUDING WITHOUT LIMITATION ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR OF FITNESS FOR A PARTICULAR PURPOSE. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION CONTAINED HEREIN.

THE FOREGOING IS THE FULL EXTENT OF THE RESPONSIBILITY OF BIG LIFT LLC AND IN NO EVENT SHALL BIG LIFT LLC BE LIABLE FOR CONSEQUENTIAL DAMAGES, DELAY CAUSED BY DEFECTS, OR ANY CHARGES OR EXPENSES OF ANY NATURE INCURRED WITHOUT ITS WRITTEN CONSENT.

BIG LIFT LLC batteries and chargers (other than built-in chargers) are subject to the following warranty schedule: BIG LIFT LLC Steel Clad industrial batteries are warranted for **sixty** (60) months from date of shipment against defective material and/or workmanship. The first thirty-six (36) months of warranty are unconditional; the following **twenty-four** (24) months are pro-rata. Transportation not included.

BIG LIFT LLC polycase industrial batteries are warranted for **three-hundred sixty** (360) days from date of shipment against defective material and/or workmanship. The first **ninety** (90) days of warranty is unconditional, the following **two-hundred seventy** (270) days is pro-rata. Transportation not included.

BIG LIFT LLC separate industrial chargers are warranted for **twelve** (12) months from date of shipment against defective material and/or workmanship. Transportation not included.

Industrial batteries and chargers other than those regularly supplied by BIG LIFT LLC will carry the terms of the manufacturer.

Except for the removal of defective parts and replacement with parts supplied by BIG JOE, the warranty for any part or equipment will be void if an attempt is made by anyone to alter, repair, disassemble, or add additional components or devices to the truck without the express written authority of BIG LIFT LLC.

Before warranty can be considered, a warranty registration and installation form must be completed and received by BIG LIFT LLC. To obtain the best service from your new BIG JOE, read the Operating & Maintenance sections of your operator's manual before initial use.
